Tom Vick: Questioned if the tree encroaching on a canal is included in the zoning enforcement report. Would like to see addresses on report.

Mr. Columbo: How many units in building?

David Clabuesch: As the developer he is aware of the right of way concerns. He has been in contact with the attorney representing homeowners and understands their reading of the easement. He will try to work with homeowners. Stated there is a need for quality rooming in Huron County.

Blaine Buchholz: Interested in the process to get a bike path on Crescent Beach and would like to pursue the plan. Would like the information available to taxpayers in a public meeting.

Todd Talaski: Updated Board on County issues.
