Public Comments:

Doug Wrock: Questioned the installation of pickleball courts.

Lee Steinman: Has been having a problem with geese. He installed an electric fence which helped quite a bit. He did not realize he needed a fence permit until he got a citation. He will remove the fence tomorrow, but stated the geese problem will continue to increase.

Shannon McCain: She is against the campground on Crescent Beach Road. She does not want 90 strangers on 9 1/2 acres next to her house. As adjacent property owners she should have received a notice about any special use permits for the campground. The original special use permit should have expired within one year if not being used as intended.

Kathy Meyer: Questioned if the Township had any written regulations regarding rental properties. She can provide information on how they are being regulated in Mackinaw City.

Board Comments:

Platko: Suggested Steinman contact the DNR about the goose issue. Stated that the Planning Commission has been discussing the rental issue and that enforcement is an issue.

Marrocco: Felt the Township should be proactive in regulating rentals and the HOA's should have input into the regulations. She is sympathetic on the goose issue and electric fencing should be allowed to regulate the population and the ordinance preventing action (fencing) should be addressed. She felt a harvest would be beneficial and asked that she be assigned to talk to the DNR.

Platko: There will be an Open House on the proposed Master Plan on August 24, 2023 from 5 p.m. to 7 p.m.
