June 4, 2018**

Meeting called to order at 4:00 p.m. by Ben Willenberg.

Motion by Marrocco second by Stirrett to approve the May 7, 2018 Board minutes, the May 21, 2018 Special Board minutes, Treasurer's Report and invoices in the amount of \$50,629.82. **Motion carried.**

Supervisor Update: Willenberg reported that the Township is working toward developing a survey to help determine the use of the Township property and recreation development; he is seeking bids for the demolition of all or some of the buildings on the property; and intends to include mosquito suppression in the survey.

Correspondence: Letter from Tom Narlock requesting mosquito suppression was read. Discussion was held on Sebewaing' s procedures for spray, costs, 2013 survey results, possible ballot proposal for registered voters and effects of high water.

Todd Talaski gave an update on County issues.

Tom Vick: Suggested Sebewaing be contacted to see how it was done and the effectiveness. Questioned if a complainant feels there is no action being done on a complaint, will the Township take action. How is blight enforced?

Wendell Shier: Suggested the use of a household insecticide product called Tempo to control mosquitos and other insects.

Chuck Kloka: The drive through, featuring coffee and sandwiches, at the laundromat will be open in a few weeks.

Dufty: If a mosquito suppression millage is passed, it will be assessed to all parcels whether or not there is a homestead.
